Mother's Day Perfume Playground Workshops Promotion Queensgate

Terms and Conditions of Entry

1. Information on how to enter and workshop information form part of these conditions of entry. Booking into the workshops is deemed acceptance of these terms and conditions.
2. The promotion is open to New Zealand residents 13 years and over. Employees of the Promoter and any agency involved with this promotion, including any tenants or retailers at Queensgate Shopping Centre, and the immediate families of such employees, are not eligible to enter. Immediate family includes the spouse, defacto spouse, child, parent, or sibling.
3. The promotion consists of perfume workshops available on 6 and 7 May 2017 at 10am, 12pm, 1pm and 3pm. ("Promotional Period"). There are 14 slots available per session per day.
4. Places per session are strictly limited to 14 people (the entrant plus their guest). Places will be allocated on a first in first serve basis. If all places fill up, then no new spaces will be made available.
5. To book into a workshop, a participant must:
 - a) Visit the booking form at queensgateshopping.co.nz
 - b) Complete all required information fields
 - c) Select a preferred time slot/date
 - d) Accept the terms and conditions
6. Only one slot is allowed per person.
7. By agreeing to the terms and conditions and booking into a workshop, the participant agrees to becoming a Queensgate Shopping Centre VIP and to receiving communications about further offers and promotions.
8. In the event that any workshop or any part of the promotions becomes unavailable for any reason beyond the Promoter's control, the Promoter may in its sole discretion decide to

provide an alternative time slot, date or end the promotion.

9. Neither the Promoter nor any other entity associated with this competition will be responsible for any late, lost, misdirected, corrupted, incomplete or incorrectly submitted entries, including but not limited to entries not received due to technical problems or human error. The time entries are deemed to be made will be the time the entry is received, not the time the entry is submitted by an entrant.
10. The Promoter reserves the right to disallow entries in its absolute discretion and without giving reasons.
11. The Promoter reserves the right, at any time, to verify the validity of entries and determine the eligibility of participants (including a participant's identity and age) and to disqualify any entry or refuse to accept an entrant where false or misleading details have been given by an entrant, or where an entrant has behaved in a fraudulent or dishonest manner, or otherwise than in accordance with these terms and conditions or the spirit of the promotion.
12. By entering this Promotion, participants agree to the use of their names, photographs and likeness for promotional/advertising purposes without charge, and agree to make themselves reasonably available for this purpose. The ensuing copyright will rest with the Promoter, without any claim to compensation from the entrants.
13. The workshops takes place at Queensgate Shopping Centre.
14. The participants acknowledge and agree that he or she will comply with all instructions given by employees of the Promoter and other agencies associated with this promotion, and agree not to do anything that may bring the Promoter into disrepute.
15. The participants agree that as a condition of entering the promotion, he or she may be required to execute a waiver and indemnity in the form provided by the Promoter.
16. If a participant cannot attend the workshop for any reason, that participant will be void and no compensation will be payable.
17. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
18. All decisions made by the Promoter, its employees or agents are final and no correspondence will be entered into.
19. The Promoter may amend, suspend or cancel any aspect of the promotion (including any prize) at any time at its sole discretion.
20. Except for any liability that cannot be excluded by law, the Promoter (including its officers, directors, shareholders, employees, advisors, assignees, agents, licensees, representatives,

advertising and promotional agencies), excludes all liability (including negligence), for any personal injury or any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where attributable to any of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected ; (d) any variation in the prize; (e) any tax liability incurred by a claimant or entrant; or (f) use of a prize.

As a condition of participating in the promotion, the winners indemnify the Promoter, all organisers, sponsors and all other persons and organisations associated in any way with the promotion against all claims, damages, liabilities, costs and expenses (including legal fees on a solicitor and client basis) which the winner may incur arising out of their participation in the promotion and/or using the prize, howsoever caused.
22. The Promoter collects and holds personal information provided by entrants for the purposes of this promotion and to advise details of further promotions by mail, email or text. Failure to provide requested personal information may disqualify a person from being able to receive a prize.
